**SECTION 4: FIRST AID MEASURES****4.1 Description of first aid measures**

<b>General advice</b>	Move out of dangerous area. Remove contaminated clothing immediately and dispose of safely.
<b>Inhalation</b>	Move to fresh air. Keep patient warm and at rest. If symptoms persist, call a physician.
<b>Skin contact</b>	Wash off thoroughly with plenty of soap and water, if available with polyethyleneglycol 400, subsequently rinse with water.
<b>Eye contact</b>	Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes.
<b>Ingestion</b>	When swallowed accidentally, do not induce vomiting, get medical help. Rinse mouth. Keep patient warm and at rest.

**Symptoms** No symptoms known or expected.

**4.3 Indication of any immediate medical attention and special treatment needed**

**Treatment** There is no specific antidote. Treat symptomatically. Gastric lavage is not normally required. However, if a significant amount (more than a mouthful) has been ingested, administer activated charcoal and sodium sulphate.

## SECTION 6: ACCIDENTAL RELEASE MEASURES

### 6.1 Personal precautions, protective equipment and emergency procedures

Iprodione caused at high dose levels an increased incidence of tumours in the following organ(s): liver, testes. The mechanism that triggers tumours in rodents and the type of tumours observed are not relevant to humans.

**Assessment toxicity to reproduction**

Iprodione did not cause reproductive toxicity in a two-generation study in rats.

**Assessment developmental toxicity**

Iprodione caused developmental toxicity only at dose levels toxic to the dams. The developmental effects seen with Iprodione are related to maternal toxicity.
